## DESCRIPTION OF TRAVEL INSURANCE COVERS. Medical expenses due to illness and accident

If the insured unexpectedly falls ill or has an accident during a trip, ZURICH will cover the expenses listed below during the term of the contract and up to a limit of €7,000 per policy period and for each insured:

- Medical fees.
- Drugs prescribed by a doctor or surgeon.
- Hospitalisation costs.
- Cost of an ambulance ordered by a doctor for a local journey.

If ZURICH has not been directly involved, these expenses will only be refunded if original invoices are submitted accompanied by a full medical report including the history, diagnosis and treatment in order to establish the nature of the unexpected illness.
